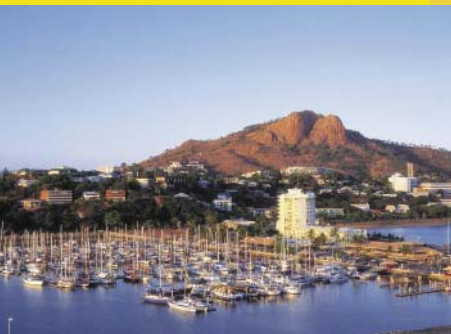

The scholarship is in memory and recognition of the contribution of Jenny Slade to innovation and the advancement of networks within local government community services. Jenny was Manager of Community Services in Springvale, Victoria from 1984 until her untimely death in 1990. The scholarship is funded by donations.

KEYNOTE SPEAKERS

Kirsty Sword Gusmão	Kirsty Sword Gusmão is the Founding Director of the Alola Foundation, an NGO established to address the needs of East Timorese women survivors of rape and other forms of gender based violence. She is also Founder of the Xanana Gusmão Reading Room, Dili, East Timor. Kirsty holds a Bachelor of Arts and a Diploma in Education (Italian/Indonesian) from the University of Melbourne. She has held positions on numerous boards including Board of Management of the East Timor Human Rights Centre (Melbourne); Director, Fund for East Timor, USA; Patron, Fundasaun Hadomi Timor Oan (Orphanage, Dili, East Timor); Founding Member, Dili Institute of Technology and Member, Board of Directors, Uma Fukun Timor (East Timor Cultural Centre). Kirsty has also published several articles.
Dr Lillian Holt	Lillian Holt was appointed a University of Melbourne Fellow in 2003. Formerly, she was the Director, Centre for Indigenous Education, University of Melbourne. She has a BA with majors in English and Journalism (University of Queensland) and an MA from the University of Northern Colorado, USA. She is currently enrolled in a PhD at Melbourne University; the topic is Aboriginal Humour. Lillian's substantive position before coming to take up her appointment(s) at Melbourne University, was Principal of Tauondi (pronounced Town-dee) which was an Aboriginal Community College in Port Adelaide. She worked there for sixteen years, the last seven as Principal.
Dr Sev Ozdowski OAM	Until his appointment as Human Rights Commissioner and Disability Discrimination Commissioner in December 2000, Sev Ozdowski OAM was chief executive of South Australia's Office of Multicultural and International Affairs. He has a long-term commitment to human rights and his relationship with the Human Rights Commission dates back to the original Commission of the early 1980s. He is the author of many papers on sociology of law, human rights, immigration and multiculturalism. Born in Poland in 1949, Dr Ozdowski migrated to Australia in 1975 and has held senior positions in the Federal portfolios of the Prime Minister and Cabinet, Attorney-General's and Foreign Affairs and Trade. He has also worked as Secretary of the Human Rights Commission inquiry into the <i>Migration Act 1958</i> and for the Joint Parliamentary Committee on Foreign Affairs, Defence and Trade.
Jon Hawkes	Jon Hawkes is an independent advisor specialising in cultural issues currently in receipt of a Community Cultural Development Board (Australia Council) Fellowship. He is author of 'The Fourth Pillar of Sustainability: culture's essential role in public planning' (Cultural Development Network (Vic) & Common Ground, 2001) and has been Director of Community Music Victoria since early 2001. He was the Director of the Australian Centre of the International Theatre Institute for eight years (1991-1998), Director of the Community Arts Board of the Australia Council (1982-1987) and founding member of Circus Oz and the Australian Performing Group. Rick Farley	Rick Farley is the Managing Director of the Farley Consulting Group, which specialises in land use agreements. He is the chairman of the NSW Resources and Conservation Assessment Council, the chairman of the Lake Victoria Advisory Committee, the chairman of the Community Forum for review of the management plan for Kosciuszko National Park, and an Ambassador for Reconciliation. He worked for rural organisations for 20 years and was the Executive Director of the National Farmers' Federation and the Cattlemen's Union of Australia. Rick now provides advice to a range of development companies and Aboriginal communities throughout Australia. He delivered one of the Barton Lectures for the Centenary of Federation in March 2001 and the 2003 Australia Day Address.
Mike Salvaris	Mike Salvaris has worked for 9 years as a Senior Research Fellow at Swinburne's Institute for Social Research. From 1997 he has been a member of the Reference Group for the Australian Bureau of Statistics' and Department of Social Security's 'Living Standard Project' developing new national indicators of well-being. Mike has worked at the Victorian Council of Social Service on children's rights, poverty and welfare policy; was on the national executive of the Australian Federation of Consumer Organisations; been Chairperson of the Inner-Urban Regional Council for Social Development (Victoria); been policy coordinator for the Victorian ALP and then Senior Policy Advisor to the (then) Premier, John Cain. He has conducted a three-year project working with a number of local governments (in Victoria and NSW) to develop local citizen-based audit and benchmark processes, aiming to promote better democracy and more responsive local government (1999-2001).
Dr Geoffrey Woolcock	Dr Geoffrey Woolcock is the Research Manager at the University of Queensland's Community Service and Research Centre, Ipswich. He has 14 years community based research experience, nationally and internationally, in housing, youth and health sectors. He has a committed intellectual and experiential interest in community activism and social reform, especially the evolution of progressive social movements. He is currently working with the LGAQ on the Local Government Social Capital Action Research Project.
Jennifer Bott	Jennifer Bott is the Chief Executive Officer of the Australia Council for the Arts the Federal Government's arts funding and advisory body. Presiding over the organisation officially charged with enriching the life of the nation by supporting and promoting the arts, Jennifer oversees a staff of 140 and an annual budget of \$136 million. A member of the Foreign Minister's Australia International Cultural Council and the Commission for International Cultural Promotion, Jennifer is also a member of UNESCO's Australian National Commission. She is also Australia's Cultural Commissioner for the 2004 Olympics. She has a life-long interest in arts and education and her life career commitment is effective management of the not-for-profit sector.
Nic Francis	Nic Francis was born in the United Kingdom, Nic first worked in the corporate world of hospitality as well as a stockbroker, but later established the two UK charities – Furniture Resource Centre (FRC) and CREATE. He received an MBE from the British Government for services to charity. He was ordained as an Anglican priest in 1996. Nic joined the well-known Melbourne welfare and advocacy organization, the Brotherhood of St Laurence, as executive director in July 1999 and in 2001 co-founded the Social Entrepreneurs Network (SEN), of which he is now Chairman. Nic is a Visiting Fellow at the Institute of Social Research at Swinburne University 2002 and an Advisory Board Member with the Melbourne Institute of Applied Economic and Social Research 2000. The Schwab Foundation also recognized him as one of the world's leading Social Entrepreneurs at the World Economic Forum's annual meeting in New York 2002.
Martin Brennan	Martin Brennan is the Manager, Partnerships and Political Support for the International Council for Local Environmental Initiatives - Australia / New Zealand (ICLEI A/NZ). Martin was appointed to this position in 1998 following three years with the Australian Local Government Association as the National Facilitator for Regional Cooperation and Development. As a former Melbourne City Councillor for 9 years, he has a long association with local government as both an elected representative and professional. Martin is a Vice President of the Victorian Local Governance Association, representing local councils, community organisations and individuals.
Anna Howe	Anna Howe has 25 years experience in research and policy development in aged care in Australia and internationally. Her research and policy development work together are widely recognised as having had a significant influence on shaping the development of aged care services nationally and in Victoria in particular. Her recent consultancies in Australia include work for the Commonwealth and State Governments, on the interfaces between acute care and aged care services and a review of the Tasmanian Aged Care Assessment Program. Anna has brought her research and policy skills to bear on aged care services at the local level through membership of aged care committees in the City of Manningham and the City of Moreland.
Tim Muirhead	Over the last 18 years Tim Muirhead, of CSD Network has amassed wide experience in all aspects of community, cultural and organisational development. The CSD Network, established in 1993, specialises in these fields, working with all spheres of government and the non-government sector. He works in a wide range of capacities, from volunteering in local community groups through to advising on policy and CD strategies to various government departments. Tim has worked extensively with Aboriginal communities, particularly through his work as WA Coordinator of Australians for Reconciliation. This project included a number of large undertakings, including a state-wide consultation (which directly reached 2000 people) and both community and logistical development and management of the Reconciliation Bridge Walk, which saw 40,000 – 50,000 people walk in support of Reconciliation. Tim is the author of <i>"Weaving Tapestries – a handbook for building communities"</i> and provides extensive training in various aspects of community development, including 'working effectively with Aboriginal communities'.
